1. **Purpose of the event:**
Test and set drive of your race car with the aim of optimizing driving safety, discipline and accident prevention. Meaning of the event is not reaching maximum speed of the vehicle. Races with other participants during the event is prohibited.
2. **Participants:**
Participation is open to all individuals who have reached the age of 18 and have a valid driver's license. Carrying a passenger is permitted only in exceptional cases, and requires the written approval of MH-Sport Promotion. All participants, including any passenger must wear the prescribed safety clothing and helmet. You must comply with the general safety regulations in motor sport. By submitting an entry, the driver recognizes to know the international motorsport regulations.
Participants undertake to follow the instructions of the organizer, its agents or other helpers at any time. They also agree to visibly wear the marking tape handed out by the organizer over the entire duration of the event and produce it on demand.
3. **Eligible Vehicles:**
Open to all Touring Car and GT vehicles, except open-top vehicles (convertibles), which correspond to the general current safety regulations in motorsport and adhere to the maximum sound level values according to the noise rules of NÜRBURGRING GmbH 1927 (NBG). The applicable noise regulations are available for inspection in MH-Sport Promotion administrative checks office. **All vehicles must be equipped with a roll cage.** Eligible vehicles can only be refuelled via the Nürburgring fuel pumps.
4. **Entry fee:.**
The entry fee is € 440, - and is payable prior to the event.
5. **Disclaimer:**
Disclaimer of drivers and of the owner: See page 2
6. **Responsibility:**
The participants (driver, possibly. Passenger) participate at their own risk in the event. They bear the sole civil and criminal responsibility for all the damage caused by themselves or their used vehicles, also guardrail damage. The participant is aware that penalties of at least € 5,000.00 may be imposed (due to the regulatory approvals for operation on the Nürburgring) for repeated breaches of the noise regulations. In case of particularly severe violations discontinuation of the event may be disposed by the NBG.
Driver and owner of the vehicle shall be liable jointly and severally for such penalties and all costs incurred in connection with a possible discontinuation of the event jointly and severally.
